RELEASE OF LIABILITY, WAIVER OF CLAIMS, ASSUMPTION OF RISKS AND INDEMNITY AGREEMENT. PLEASE READ CAREFULLY, BY SIGNING THIS DOCUMENT YOU WILL WAIVE CERTAIN LEGAL RIGHTS, INCLUDING THE RIGHT TO SUE.

TO: **BEAR BASIN OUTFITTERS** representatives  
(ALL of whom are collectively referred to as “**BEAR BASIN OUTFITTERS**”).

I AM AWARE that my participation on any activity at **Bear Basin Outfitters** involves exposure to RISKS, DANGERS and HAZARDS which may be greater or different than those I normally encounter. Such RISKS, DANGERS and HAZARDS include but are not limited to: travel and survival in the wilderness; inadequate physical fitness or endurance; the use of defective equipment; changing weather conditions; varying environmental conditions; varying wilderness conditions; encounters with and attacks by wild animals; negligence on the part of **Bear Basin Outfitters**; negligence on the part of fellow guests. Use of woodstoves, firearms, livestock and other hunting equipment.

I AM FURTHER AWARE THAT I may be exposed to RISKS, DANGERS, and HAZARDS NOT listed above.

I FREELY ACCEPT AND FULLY ASSUME any and all such RISKS, DANGERS and HAZARDS and the possibility of PERSONAL INJURY, DEATH, PROPERTY DAMAGE or LOSS resulting from such RISKS, DANGERS, and HAZARDS.

I AGREE TO COMPLY WITH THE DIRECTIONS and INSTRUCTIONS of **Bear Basin Outfitters** before and throughout the stay.

IN CONSIDERATION of **Bear Basin Outfitters** accepting my application and permitting my stay, I HEREBY AGREE as follows:

I ASSUME AND ACCEPT ANY and ALL RISKS, DANGERS and HAZARDS arising out of, incidental to, or in any way connected with my stay;

I WAIVE ANY AND ALL CLAIMS, ACTIONS, COSTS, EXPENSES AND DEMANDS that I may have against **Bear Basin Outfitters**;

I RELEASE **Bear Basin Outfitters** from any and all liability for any LOSS, DAMAGE, INJURY, or EXPENSE that I, or my next of kin, may suffer or incur as a result of my stay, due to any cause whatsoever, including negligence on the part of **Bear Basin Outfitters**;

I HOLD HARMLESS AND INDEMNIFY **Bear Basin Outfitters** from any and all liability for property damage, personal injury or death suffered by myself or by a third party as a result of my participation on the trip;
